- 2 Cost of materials consumed represents only Green Leaf purchased from third parties.
- The Company is primarily engaged in the business of cultivation, manufacture and sale of tea and is a single segment company.
- The figures of the last quarter of the previous year are the balancing figures between audited figures in respect of the full financial year and the published year-to-date figures upto the third quarter of the respective financial year.
- As the Company is engaged in the business of Cultivation, Manufacturing and sale of tea which is seasonal in nature, figures for the quarter ended 30th June 2014 are not construed as representative of likely result for the year ending 31st March, 2015.
- As the ultimate income tax liability will depend on results for the year ending 31st March 2015, in view of the seasonal nature of tea business, the position with regard to Current Tax and Deferred Tax will be determined at the end of the year.
- During the quarter, depreciation has been provided as per schedule II of the Companies Act, 2013 which has been made effective from 1st day of April 2014. Accordingly, carrying amount of assets as on 31st March, 2014 have been depreciated over the remaining useful life of the assets recomputed as above. Consequently, depreciation for the quarter is higher by Rs.2.10 Lakhs.
- 8 Previous periods' figures have been re-arranged/re-grouped wherever necessary.
